Beginning Farmer Bonds (One-Time Final Resolution)

### 1A) <u>Cory James Funk - \$196,100 – 72 acres</u>

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$196,100 for the purchase of approximately 72 acres of farmland. This project is located in Lawrence Township, Lawrence County, IL.

#### 1B) Alexander Colby Jordan - \$226,879 – 40 & an undivided ½ interest in 39 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$226,879 for the purchase of approximately 59.5 acres of farmland. This project is located in Bois D'Arc Township, Montgomery County, IL.

#### 1C) Korey P. Jordan - \$226,879 – 40 & an undivided ½ interest in 39 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$226,879 for the purchase of approximately 59.5 acres of farmland. This project is located in Bois D'Arc Township, Montgomery County, IL.

## 1D) John A. Olson - \$475,000 - 155 acres

Request for approval of the issuance of a Beginning Farmer Bond in an amount not-to-exceed \$475,000 for the purchase of approximately 155 acres of farmland. This project is located in Suez Township, Mercer County, IL.

## 1E) John W. & Grace E. Vaughan - \$143,750 – 40 acres

Request for approval of the issuance of a Beginning Farmer Bond in the amount not-to-exceed \$143,750 for the purchase of approximately 40 acres of farmland. This project is located in Leech South Township, Wayne County, IL.

## 1F) James A. & Anne E. Vaughan - \$143,750 – 40 acres

Request for approval of the issuance of a Beginning Farmer Bond in the amount not-to-exceed \$143,750 for the purchase of approximately 40 acres of farmland. This project is located in Leech South Township, Wayne County, IL.

## 1G) Spencer A. Janssen - \$250,000 - 75 acres

Request for approval of the issuance of a Beginning Farmer Bond in the amount not-to-exceed \$273,750 for the purchase of approximately 80 acres of farmland. This project is located in Mill Shoals Township, White County, IL.

Wherefore the threshold for a quorum had not been met, Mr. Goetz deferred the approval of the above projects to the Board Meeting to be held on December 13, 2011.
